We, the undersigned, as Officers of the _____ League, understand and agree to the following terms for the _____ season:

1. A league consisting of _____ weeks of sanctioned league bowling
2. Price of bowling will total _____ per person for _____ games based upon _____ weeks of paid bowling. Any applicable sales tax added if necessary.
3. Guaranteed league. _____ bowlers on a team. All blinds and pacers to be paid the same night.
*Pacers will pay the same amount per game as regular league members.
*After the 3rd week of bowling, vacancies shall count as regular league bowlers and be included in a full roster payment.
****If bowlers are needed for the upcoming season, please contact us prior to the summer so that we may advertise.**
4. There will be eight (8) minutes of practice bowling for all leagues.
5. League is to start bowling on _____ (date) and to bowl each exceeding _____ (weekday) night, with the exception of holidays, starting practice at _____ (time).
6. This Establishment agrees to maintain proper service and facilities, clean rest rooms, USBC Sanctioned Lanes and Pins.
7. Pre-bowl/1 Person unopposed bowling is forbidden according to USBC rule 111a; unless stated otherwise by a league Bylaw. Under such conditions a team make-up may be granted. If such a bylaw exists or a team make-up is granted, Hometown Lanes reserves the right to allow such make-ups on **SUNDAYS from 12-2PM ONLY and if lanes are available.** Arrangements must be made a least two days prior to pre-bowling; NO EXCEPTIONS.
8. **Due to State Law, there is to be no smoking anywhere in the building.**
9. **NO ONE UNDER THE AGE OF 16**, is allowed on premises during league play without a parent/guardian they are going to remain seated with throughout the night. Remember, this is an adult night out, so please be courteous to the people around you and bring activities for your child to do at the table if such circumstances cannot be avoided.
10. Any damage done by league bowlers will fall upon the league officers to resolve. If there shall be repeat offenses, Hometown Lanes reserves the right to ask the league member(s) who are committing such act(s) to leave.
11. **NO Outside Food or Beverage** will be allowed to be brought in.
12. Hometown Lanes reserves the right to postpone a league's scheduled bowling night due to weather conditions, tournaments, and/or any other unforeseen event(s). Leagues will either have to elongate the season by the number of missed weeks or make supplementary arrangements to fulfill those weeks. **League Make-Ups will not be granted during the months of January, February, & March.**
13. Hometown Lanes agrees to include a Free night of bowling at the end of the season so long that a league completes and pays for an entire 32 week season.
14. League agrees that this contract shall be binding upon any new or successor officers who may become officials during the stated season.
15. No oral representation may modify this contract.
16. League certifies that it has no agreement with any other bowling center for the period covered by this contract.
17. For the member(s) of the league that sign this contract, let it be known that they are signing on the behalf of every member in their league. Every member should know what is contained in this contact and acknowledge that they understand what they are abiding too.
