

# Hometown Lanes

We, the undersigned, as Officers of the \_\_\_\_\_ League, understand and agree to the following terms for the \_09-10\_ season :

1. A league consisting of \_\_\_32\_\_\_ weeks of sanctioned league bowling.
2. Price of bowling will total \_\_8.75\_\_ per person for \_\_\_3\_\_\_ games with any City, State, County, or Federal Sales Tax to be added to the price of bowling.
3. Guaranteed league. \_\_\_\_\_ bowlers on a team. All blinds to be paid the same night.  
\*Pacers will pay the same amount per game.  
  
\*All Vacancies must be paid for after the 3<sup>rd</sup> week of bowling. In other words, if a contract is signed for 8 lanes 4 on a team, after the third week of bowling the league will be obligated to pay for thirty two bowlers. If that same league arrives the first week with only twenty four bowlers, then they have the option to be reduced to 6 lanes or be responsible for the extra 8 bowlers.
4. There will be eight (8) minutes of practice bowling for all leagues.
5. League is to start bowling on \_\_\_\_\_ (date) and to bowl each exceeding \_\_\_\_\_ (weekday) night, with the exception of holidays, starting practice at \_\_\_\_\_ (time).
6. This Establishment agrees to maintain proper service and facilities, clean rest rooms, USBC Sanctioned Lanes and Pins.
7. League Pre-Bowling  
Thursday : 5:00pm - 9:00pm

### **When Lanes are Available.**

- \***Must notify us at least 2-days prior to pre-bowl.**
- \***Maximum of 8 times per bowler per season.**
- \***There is no Pre-Bowling on Friday, Saturday, or Sunday. NO EXCEPTIONS.**

8. No Smoking  
**Due to State Law, there is to be no smoking anywhere in the building.**
9. League Make-Ups  
**League Make-Ups will not be granted during the months of January, February, or March.**  
If we should receive the City Tournament, Leagues will have to make-up that date the following week or prior arrangements must be made.
10. With insurance rates rising due to preventable injuries occurring in the recreational sport industry, our facility has opted to go with an **Unaccompanied Child Policy**. This policy states that no child under the age of 16 will be allowed on the premises without the accompaniment of a parent or guardian who is; 1: Not participating in the sport of bowling and, 2 : Who is able to sit with them the entire night. Anyone disregarding this policy will be asked to leave the premises and take a blind for the night in their league. **NO EXCEPTIONS**
11. Any damage done by league bowlers will fall upon the league officers to resolve. If there shall be repeat offenses, Hometown Lanes reserves the right to ask the league member who is committing the act(s) to leave.
12. **NO Outside Food or Beverage** will be allowed on premises due to health department regulations.
13. For the member(s) of the league that sign this contract, let it be known that they are signing on the behalf of every member in their league. In other words, every member should know what is contained in this contact and acknowledge that they understand what they are abiding too.
